#### Preamble

The Super-Specialty Cancer Institute and Hospital is an autonomous Institute of the Department of Medical Education, Government of Uttar Pradesh. It is envisioned as a state-of-the-art cancer treatment facility; commenced treatments in the past year, and is slated to expand its repertoire to a complete range of cancer directed clinical services, including end-of-life care, under one roof. It will also train doctors in various broad specialties and sub-specialties especially focusing on cancer treatments; offer senior resident and post doctoral certificate / fellowship positions; train nurses and paramedical staff; and focus on innovation and research aimed at providing cost-effective and value-based strategies for the diagnosis and management of cancer patients.

#### Faculty

We are looking for faculty members, who besides being skilled in their respective disciplines, have a reasonable appreciation of data management and statistical inference techniques; can leverage information technology tools in their daily work; are team players; and demonstrate reasonable bi-lingual (English and Hindi) communication skills and empathy. The positions will be full time and private practice of every kind is prohibited.

The Institute is committed towards making medical care safe and in improving the most important goals of a person afflicted with cancer - of living longer and better. The treatment decisions would necessarily be made only through multidisciplinary disease management groups or interest groups, functioning in virtual or real time, and not by individual consultants. This will be accompanied by periodic and systematic audits. These audits shall be the cornerstone of patient care activities at the Institution and will guide changes in various processes to make clinical care more effective, safe and convenient to patients always conscious of costs to patients and the value they offer. These shall be a critical parameter for employee / trainee appraisals.

The institution will encourage the faculty to engage and collaborate with civil society, other educational institutions and universities, philanthropic groups, and not-for-profit-organizations, for promoting the cause of evidence-based, comprehensive patient care with a societal perspective and relevant research.

If eligible for a post you will be required to appear for a formal interview and the process may span over two days. On the first day besides a mandatory verification of your credentials (originals required to be sighted) you will be invited to spend a few hours interacting with faculty and other related assessments that may include objective multiple choice tests in the applied specialty, medical statistics, basic word processing and data handling software, and psychological assessments. This will be followed with be a formal interview, which may include creating and making a presentation on a topic which will be selected by external experts and informed on the day of the interview. Interviews may last till 5PM in the evening, so plan your visit accordingly.

If currently overseas, video-call(s) may be arranged for assessment of afore-stated process. We will also speak to your referees or others at your previous places of training / work.

# Some training requirements, duties and responsibilities of an Assistant Professor:

The mandated formal and complete training in the broad specialty i.e. MD/MS/DNB/MDS/MSc-PhD plus a senior resident /demonstrator / research experience / special training (as applicable) **OR** in a subspecialty i.e.

DM/MCh/DNB/FNB at an MCI-recognized institution in India or abroad is *sine qua non* for a position. Where relevant, experience is reckoned after the date of award of a PhD which must be mentioned accurately.

We will seek demonstrable evidence of clinical / laboratory / diagnostic skills, as appropriate, by way of log books, testimonials, and quality of published work. Clinical faculty members would be expected to be able to have the ability to independently assess and treat common diseases / relevant laboratory skills / diagnostic skills in her/his area of specialization. S/he will be expected to mentor residents and enhance her/his own skills in quality clinical service, database management, auditing of clinical data, and research, as also other skills that may become important for medical professionals at a future date. S/he will be expected to participate in collaborative or investigator-initiated research under the guidance of senior faculty members and to gradually develop own research, albeit of relevance to the institution. Opportunities will be available to participate in administrative roles, under guidance.

### Some duties and responsibilities of a Professor:

Such an individual will be required to:

- 1. Develop and augment the respective specialty and develop a clear vision of the immediate and future needs and
- 2. Have a track record of attracting external funding to further the development of clinical services / clinically relevant research areas and will be required to provide clinical and research support to faculty from other specialties
- 3. Lead the postgraduate teaching program of the concerned specialty; collaborate with other specialties as a part of the disease-management-group / Multi disciplinary Tumor board approach; design audits directed at improving patient care and joint academic programs; and mentor Assistant and Associate Professors of the specialty and
- 4. Lead a clinical program of cancer research and publish in peer reviewed international journals of the concerned specialty
- 5. Participate in Institute / Department committees and related administrative functions as assigned.

- I. A medical qualification included in the first or second schedule or part II of the third schedule of the Indian Medical Council Act, 1956. Persons possessing qualifications included in part II of the third schedule of this Act shall also fulfill the conditions specified in sub-section (3) of the section 13 of the said Act.
- II. A postgraduate qualification recognized by the Board of Governors in supersession of Medical Council of India (MCI) or equivalent thereto (i.e. if a person with postgraduate medical qualifications awarded in the United States of America, United Kingdom, Canada, Australia or New Zealand desires to take up a teaching appointment, his/her qualification can be considered as equivalent to MD/MS/DM/MCh/ Ph.D as the case may be, for the post of Assistant Professor in respective departments. Diplomate National Board (DNB) shall be treated as equivalent to MD/MS/DM/MCh qualifications of the respective broad / sub-specialties as per prevalent equivalence criteria for teaching posts in Institutes.
- III. Candidate should have completed total 14, 6 and 3 years of teaching and/or research experience at a recognized teaching institution, after the prescribed MD/PhD degree for the posts Professor, Associate Professor and Assistant Professor, respectively OR 12, 4 years and 1 year of teaching and/or research experience, respectively, after obtaining the degree of DM/MCh (2-year duration) in the concerned specialty OR 11, 3, 0 years of teaching and/or research experience after obtaining the degree of DM/MCh (3 years duration) in the respective specialty. In subjects where DM/MCh qualification is not yet mandated by the MCI, 3-years' post MD/MS experience in concerned specialty as Senior Resident at a Institute recognized by MCI for the purpose will be accepted in lieu of such qualification for the post of Assistant Professor. Prescribed duration of experience will be determined as on the last date of submission of the application form. In addition

- 1. The age limit will be relaxable for candidates belonging to scheduled castes / scheduled tribes / other backward class as per Uttar Pradesh Govt. rules / orders.
- 2. Scheduled Caste, Scheduled Tribes, Other Backward Class, Dependents of Freedom Fighter, PH., Ex-Serviceman and women candidates who are not the permanent residents of Uttar Pradesh shall not be given the benefit of reservation/age relaxation.
